



#### Yellow Medicine River Watershed



#### Mission

The mission of the Yellow Medicine River Watershed District (YMRWD) is to provide an organized means for proper management and protection of the water resources in the Yellow Medicine River Watershed. The YMRWD has three core functions outside of administration: (1) Serve as the drainage authority for systems under its jurisdiction, (2) Provide a regulatory framework that permits a variety of activities that complement the flood reduction and water quality goals of the district, and (3) carry out activities of the watershed management plan.

## History of the Yellow Medicine River Watershed

The Yellow Medicine River Watershed District (YMRWD) is a local unit of government established on August 27, 1971, through a petition of its residents to the MN Board of Water and Soil Resources. The jurisdiction of the organization covers 685 square miles in southwestern Minnesota that drain to the Yellow Medicine River in Lincoln (39%), Lyon (23%), and Yellow Medicine (38%) counties. County Commissioners appoint representatives to a 5-member board of managers that direct and oversee activities of the District. The southeast portion of the Coteau des Prairies, partially located in the southwest of the Yellow Medicine Watershed, comprises one of the distinct regions in Minnesota, known as the Buffalo Ridge. From the Coteau region, the watershed drains to the northeast with 1,125 feet of elevation change to the lower region, called the Flatland region. The Transitional region in between these two regions is where the elevation changes are the greatest, at approximately 45 feet per mile.

## Budgets

- •In 2023, the Minnesota Legislature passed a bill that increased the levy cap for Watershed Districts to \$500,000. A hearing for the 2024 proposed operation budget took place on August 16, discussion, during the regular board meeting. The Administrator presented a variety of budget options from no levy increase to a \$100,000/year increase. After discussion, the board moved to increase the levy by \$20,000 to \$260,000.
- •2024 has a budgeted income of \$380,650.00 with expenses of the same amount.

- •The District held a public Budget Hearing on September 21, 2024, at 9:00 a.m. With the \$20,000 levy increase for 2024, the administrator recommended no increase for 2025. After discussion and looking at the projected budget, the board moved to set the levy at \$260,000. The same as 2024.
- •2025 has a budgetd income of \$357,717.36 with expenses of the same amount.

# Drainage Authority Work

- The YMRWD has 9 drainage systems under its jurisdiction consisting of both tile and open ditch.
- Watershed Ditches 1, 4, 7, and 16 were inspected in 2024.
- During the inspection of WD 4 construction materials including carboard boxes, polystyrene and other various plastics were removed. Approximately 6 12-gallon garbage bags were filled with debris, that had either been dumped in the ditch or had blown into the ditch.
- Maintenance on WD 16 for sediment removal, tree removal, tile outlet repairs and culvert repairs have been scheduled for Spring of 2025 by K & K Tiling. WD cleanout will be the first excavation project on the list.
- Maintenance is scheduled to be performed in 2025 by Groundworks Drainage for WD 7 and WD 17 for culvert and tile outlet repairs.
- Beaver damage to nearby trees adjacent to WD 17 were noted but no beavers were seen.

# Regulatory Program: Permitting

The district continued its permitting program which requires that all non-maintenance drainage projects obtain a permit from the watershed district. In 2024, 128 permit applications were submitted, of which 99 were approved, 28 are currently incomplete and 1 was denied.

- Types of permits granted:
  - 44 permits approved for seepage lines only
  - 29 permits approved for new mains with seepages lines
  - 7 permits approved for new mains only
  - 7 permits approved for WASCOBs
  - 6 permits approved for culvert repairs
  - 2 permits approved for Waterway restoration or creation
  - 1 permit approved for grade stabilization
  - 1 permit approved for filling a stock pond
  - 1 permit approved for Wetland restoration
  - 1 permit approved for 2 new lift pumps

In 2022 110 tiling and drainage permits were approved

In 2023 59 tiling and drainage permits were approved

### Nuisance Beaver Program

- There was \$8,000 budgeted for the Beaver Bounty in 2024
- In 2024 we paid out \$13,145.99 with 263 Beavers being collected
- In 2023 there was \$3,000 budgeted for the Bounty program
- The District paid out \$4,647
- The District budgeted \$7,500 for the Bounty Program in 2025

## One Watershed One Plan


The YMRWD has adopted the Yellow Medicine One Watershed One Plan as the Districts comprehensive water plan. The Yellow Medicine One Watershed One Plan (1W1P) project began in 2014 as one of five pilot projects across Minnesota that set out to align watershed planning along watershed boundaries and move away from county planning boundaries. The plan was completed and approved by the MN Board of Water and Soil Resources on December 14, 2016.

Since plan implementation began in 2018, the YM River Watershed District has acted as the fiscal agent and the plan coordinator, and daily contact for the YM1W1P.


In 2024 the Partnership was approved for and received the 24/25 WBIF grant of just over 1.3 million.

In 2024, the district continued to lead the 1W1P implementation efforts, working closely with the SWCDs to increase conservation BMPs across the watershed. In the upcoming year, the district aims to continue its efforts to increase the capacity and capabilities of the office and staff to better serve the community.


# One Watershed One Plan Projects




# Acres Treated in 2024
